

## INVITATION TO BID

---

Note: This is the second round of bidding for this project. The first bid round was cancelled.

**RECEIPT OF BIDS:** Sealed bids for construction of the **Shasta River Water Association Lower South Ditch Measurement Improvements** will be received by **Shasta Valley Resource Conservation District (SVRCD)** at **215 Executive Ct., Suite A, Yreka, CA 96097**, until **2:00 pm** on **December 7<sup>th</sup>, 2018**.

**OBTAINING BID DOCUMENTS:** Copies of the BID DOCUMENTS may be obtained on or after **November 28, 2018** at the SVRCD office (215 Executive Ct., Suite A, Yreka, CA) or by calling the Shasta Valley RCD office at 530-572-3120. There will be no charge for the bid packets.

**REVIEWING BID DOCUMENTS:** Copies of the BID DOCUMENTS will be available for viewing at the Shasta Valley RCD office (location noted above) between the hours of 9:00 am and 4:00 pm Monday through Friday, except federal holidays from November 28<sup>th</sup> to December 7<sup>th</sup>.

**DESCRIPTION OF WORK:** The *Shasta River Water Association Lower South Ditch Irrigation Improvements*, called "the Project", is located in the Shasta Valley, Siskiyou County, California. This project is funded by the USDI, Bureau of Reclamation through their 2015 WaterSMART program, the State of California Water Quality Control Board through the North Coast Resource Partnership (NCRP) and the Shasta River Water Association.

The project includes the construction/installation of three (3) water control and flow measuring structures at the Lower South Ditch for the Shasta River Water Association in the Shasta Valley, Siskiyou County, California. The purpose of this project is to improve water control and measurement capabilities of the water users in the association.

This project consists of work on the SRWA Lower South Ditch at three sites:

**Lower South Ditch Irrigation Improvements:** includes the construction of three (3) new irrigation division control structures consisting of new concrete measuring and division flume boxes. The exact location of the three boxes will be determined in the field by SRWA staff.

The contractor must understand and provide the proper connections for the electronics which will be procured and installed outside of this contract.

Flow meters will be installed within each flume with cabling contained within 2" conduit trenched to the control box with a minimum two-foot burial depth. Flow meters will be connected to a data logger which will then be connected to the Watch Technologies (or equivalent) sluice gate control box. The telemetry described above is going to be installed under a separate contract. Some coordination will be needed.

The placing of orders for components for this job must be started within two weeks of the notice to proceed.

Contractor agrees to be bound by all the provisions of the California State Labor code regarding prevailing wages and shall monitor all contracts subject to reimbursement from this Agreement to assure that the prevailing wage provisions of the Labor Code are being met. The Contractor is expected to submit certified payroll on an established schedule to the Department of Industrial Relations. This project is a public works project; therefore the following statements apply:

-No contractor or subcontractor may be listed on a bid proposal for a public works project unless registered with the Department of Industrial Relations pursuant to Labor Code section 1725.5. **CONTRACTORS AND SUBCONTRACTORS MUST BE REGISTERED PRIOR TO SUBMITTING BID.** Register at DIR website: <https://www.dir.ca.gov>. If you have listed non-registered contractors your bid will be rejected by the OWNER.

-No contractor or subcontractor may be awarded a contract for public work on a public works project unless registered with the Department of Industrial Relations pursuant to Labor Code section 1725.5.

-This project is subject to compliance monitoring and enforcement by the Department of Industrial Relations. For this project, certified payroll must be filed electronically with DIR by the contractor.

**PAYMENT SCHEDULE NOTE:** This project is grant funded. It is common practice that the contractor is paid within 15 days of receipt of payment from the grantor to SRWA, but payment from the grantor can take as long as six months from the date of invoice. Efforts will be taken by the SRWA and the SVRCD to expedite payment to contractors.

**PRE-BID SITE VISIT:** Contractors wishing to bid on this project may request a pre-bid site visit to be scheduled by the SRWA Board of Directors. Please contact Rick Lemos at 530-598-6922 to schedule a field visit.

**LICENSE AND INSURANCE:** All Contractors must be licensed in the State of California in the category of work to be performed on this project. The successful bidder will be required to provide proof of insurance that meets requirements set forth in contract.

**BONDING:** The successful BIDDER will be required to furnish Performance and Payment Bonds, each in the amount not less than **100%** of the contract price. All bidders must submit a Bid Security equal to 5% of the bid price.

**ADDRESS AND MARKING OF BID:** The envelope enclosing the attached bid form shall be sealed and addressed to **Shasta Valley Resource Conservation District** and delivered or mailed to **215 Executive Ct., Suite A; Yreka, CA 96097** no later than **2:00 pm on December 7<sup>th</sup>, 2018**. The envelope shall be plainly marked in the upper left-hand corner with the name and address of the bidder and shall bear the

words "Bid for SRWA Lower South Ditch Irrigation Improvements.

**PROJECT ADMINISTRATION:** Contract administration and limited construction administration will be performed by the Shasta Valley Resource Conservation District. Construction management will be provided by the Shasta River Water Association.

All questions relative to this project prior to the opening of bids shall be directed to the SVRCD Project Manager in writing. It will be understood that no interpretations of the specifications will be made by telephone, nor will any "or equal" products be considered for approval prior to award of contract.
