



## **INVITATION TO BID**

### **Shasta River Riparian Stewardship Project**

### **Sandahl Ranch - Fencing**

RECEIPT OF BIDS: Sealed bids for construction of the Shasta River Riparian Restoration Fencing – Sandahl Ranch will be received by the Shasta Valley Resource Conservation District, 215 Executive Ct., Suite A, Yreka, CA 96097, until **Sept. 11<sup>th</sup>, 2019** at or before 2pm.

OBTAINING BID DOCUMENTS: Copies of the BID DOCUMENTS may be obtained on or after **August 20<sup>th</sup>, 2019** by calling the SVRCD at 530-680-7118 or stopping at the SVRCD office. If you plan to obtain bid documents at the pre bid tour, please email [groberson@svrkd.org](mailto:groberson@svrkd.org) to give notification of your interest in doing so.

REVIEWING BID DOCUMENTS: Copies of the BID DOCUMENTS will be available for viewing at the Shasta Valley RCD (location noted above) between the hours of 9 am and 4 pm weekdays, except holidays.

DESCRIPTION OF WORK: The California State Water Resources Control Board has awarded 319h Clean Water Act – Nonpoint Source Implementation funds to the SVRCD to implement projects that will improve water quality by decreasing water temperatures in the Shasta River, an important tributary to the Klamath River, through improved agricultural water management.

This project is to be implemented on the Sandahl Ranch located in the Shasta River area of Siskiyou County, California. The components to this project are,

- Construction of 1700' of barbed wire fence. (see below fencing installation specs).
- Construction of a stockwater trough. Installation of necessary buried pvc piping from a well, construction of a rubber tire trough and float, apron and other appurtenances
- Planting willow poles along approximately 400' of an unnamed tributary of the Shasta River.

Contractor agrees to be bound by all the provisions of the California State Labor code regarding prevailing wages and shall monitor all contracts subject to reimbursement from this Agreement to assure that the prevailing wage provisions

of the Labor Code are being met (see attached) Labor Compliance Pre-Construction Information Resource Handout). The Contractor is expected to submit certified payroll on an established schedule to the Department of Industrial Relations. This project is a public works project; therefore the following statements apply:

-No contractor or subcontractor may be listed on a bid proposal for a public works project unless registered with the Department of Industrial Relations pursuant to Labor Code section 1725.5.

**CONTRACTORS AND SUBCONTRACTORS MUST BE REGISTERED PRIOR TO SUBMITTING BID.** Register at DIR website: <https://www.dir.ca.gov>. If you have listed non-registered contractors your bid will be rejected by the SVRCD.

-No contractor or subcontractor may be awarded a contract for public work on a public works project unless registered with the Department of Industrial Relations pursuant to Labor Code section 1725.5.

-This project is subject to compliance monitoring and enforcement by the Department of Industrial Relations. For this project, certified payroll must be filed electronically with DIR by the contractor.

**PRE-BID SITE VISIT:** CONTRACTORS wishing to bid on this project should attend a mandatory pre-site visit scheduled on **August 27th, 2019 at 8:30 am** at 215 Executive Ct, Suite A, Yreka CA. Representatives of the SVRCD will be present to discuss the project. Contractors shall come prepared to walk the fencing alignment.

**BONDING:** The Successful BIDDER will be required to furnish Performance and Payment Bonds, each in the amount not less than 100% of the contract price. All bidders must submit a Bid Security equal to 5% of the bid price.

**ADDRESS AND MARKING OF BID:** The envelope enclosing the bid shall be sealed and addressed to the Shasta Valley RCD (SVRCD) and delivered or mailed to 215 Executive Ct., Suite A, Yreka CA 96097 no later than 2pm on **September 11<sup>th</sup>, 2019**. The envelope shall be plainly marked in the upper left-hand corner with the name and address of the bidder and shall bear the words "Bid for Shasta River Sandahl Fence" and the date.

**PROJECT ADMINISTRATION:** All questions relative to this project prior to the opening of bids shall be directed to Gillies Robertson, the Project Manager for the project. It shall be understood, however, that no interpretations of the specifications will be made by telephone, nor will any "or equal" products be considered for approval prior to award of contract.

**SVRCD'S RIGHTS RESERVED:** The SVRCD reserves the right to waive any informalities or to reject any or all bids, if in the best interest of the SVRCD.
